ART FAIR APPLICATION

EVENT FACTS:

Where: The Hill, Grosse Pointe Farms. (The Hill Municipal Lot – 41 Kercheval Ave.)

When: Saturday, August 7th 10am - 6:00pm and Sunday, August 8th 10am – 6pm.

Cost: \$50 per 10 x 10 space. Artists must supply their own table/chairs and tent/canopy.

Clean Family Fair! No vulgarity, or obscenities will be tolerated.

REQUIREMENTS:

A minimum of 3 photos must be submitted to show artist's work. (Online by email attachment or website is acceptable). Photos may also be mailed.

All mediums are welcome. Categories include paintings, prints, photography, jewelry, glassworks, metalworks, ceramics, sculpture, clothing, graphic design, etc. Products must be designed and produced by the artist. (Only 8 spaces for jewelry)

All entries must be in good taste and “family friendly”. All applications will go before the art fair committee for review at which point exhibitors will be notified of their approval. Upon their approval, \$50 fee must be paid upon receipt.

The Grosse Pointe Chamber reserves the right to accept or decline any applicant as it deems necessary and may remove all or part of an exhibit that it deems in violation of the rules. Decisions are final.

Artists are required to be present on both days.

SET UP

The Chamber will have spaces identified and you can set up beginning at 8am Saturday, August 7th. There is no electrical power source available. You are responsible for bringing your own table/chairs/booth/tent.

Please remember that use of your interior space is YOUR responsibility – display, making sales, collecting State of Michigan sales tax (6%) and reporting those sales to the State.

Check for entry fee of \$50 should be made payable to “**Grosse Pointe Chamber of Commerce**”
